





The impact functionality will also outline the time, date operator involved and severity of the incident.

Identify at a glance your most valuable operators and one that may require re-training.



Being able to identify who, what why and where damage is occurring you re then able to introduce necessary actions to reduce the cost associated with this, whether that be driver training adjustments to site layout or even repair to uneven and damaged surfaces.
